# **Out and About**

The recent Our Voice Our Future conference highlighted that as individuals we have the need to show leadership to implement change. Leadership is not a specific job title, but instead the desire to make something happen and to initiate and act upon a plan to effect change. There were many



great initiatives that were focused on, and FACT took the opportunity to be involved in discussions on the need for bipartisan support at federal and state levels in reducing child poverty and increasing child wellbeing. The discussion focused on the need to build enduring political accountability, consensus, and action to address the issue of poverty for families and their children. A bipartisan approach at both the state and federal levels would enable Australia to set targets, with agreed measurements, and ultimately a strategy that all sides of politics agree that we should be working towards. With our neighbours in New Zealand committing to a Child Reduction Poverty Bill, perhaps it is now time for Australia and our states to commence the conversation.

Recently FACT attended the discussion on "Next Steps for National Policy on Child and Family Wellbeing" that was facilitated by Families Australia. This discussion provided us with an opportunity to be briefed by Gail Eaton-Briggs from the Department of Communities on the number of key initiatives that Tasmania has underway, as well as reflect on the issues that the national framework needed to address including:

- \* A three-fold increase across Australia in the number of children in out-of-home care in the past two decades from 14,470 to 45,756
- \* The rate at which Aboriginal and Torres Strait Island children are in out-of-home care (58.7 per 1000) is 10 times the rate for non-indigenous children.
- \* An 11% increase in the number of children receiving child protection services in the past five years (143,000 to 157,000).
- \* Last year, the total national spend on child protection & related family supports was \$5.8 billion (10% real increase from 2016-17), of which out-of-home care services were 59 per cent, or \$3.4 billion.
- The large number of children in informal kinship care arrangements across Australia who have inadequate access to financial resources, therapeutic services and carer support including training.

In other news, The Department of Communities has released a draft Companion Document to compliment the OOHC Outcomes Framework that was released by the Minister late last year. The purpose of this Companion Document is to identify and implement measurements in relation to achieving the outcomes identified in the framework. FACT has been asked to provide feedback on the Companion Document by the end of April.
