Report from the Chair

It has been a busy couple of months at FACT with the Board being active in the advocacy space. We have organized several forums on Safe Families Safe Kids and the Child and Youth Wellbeing Strategy. A budget submission for FACT to receive a minimal amount of funding to support our activities has been submitted to Treasury.

Since the election was announced FACT has been working with TASCOS on the development of a sector wide election priorities and you can read about those [here](#). FACT has also prepared a budget statement for the election. A summary of this statement is as follows:

FACT support the Tasmanian Community Services Industry Joint Statement of 2021 State Election Priorities and knows that the Community and Social Services industry is critical to the wellbeing of Tasmanians and therefore our economy.

FACT particularly supports the implementation of a minimum five-year funding models for Tasmanian community service organisations which support transparent, adaptable, community led and place-based solutions and service delivery to enable the organisations to deliver their services on a safe and stable footing.

FACT urges political parties to consider the development of a robust model for the commissioning of services that places Government and Departments in their proper role of governance and oversight and removes the conflict of interests that currently exist with Government being both a provider and competitor of the not-for-profit sector.

FACT calls upon all political parties and representatives to consider the needs of children, young people and their families when developing policy positions.

FACT calls for political parties to adopt policies that ensure:

- Families have a place to call home and that no child is homeless.
- Tasmania’s vulnerable children are cared for in Tasmania and not sent interstate for treatment or support.
- Children living in Out of Home Care have their health needs, including mental health, prioritised.
- Families have the support that they need to care for their children.
- Kinship carers have access to the same support and resources as foster carers.

SECTOR UPDATES

STRONG FAMILIES SAFE KIDS UPDATE

In 2016, Children, Youth and Families commenced the [Strong Families Safe Kids Implementation Plan 2016-2020](#), an ambitious long term system reform agenda.

The Department of Communities has now released the [Strong Families Safe Kids: Next Steps Action Plan 2021-2023 \(Strong Families Safe Kids: Next Steps\)](#) which continues the journey of changing the way government and non-government services work together to shift the curve and improve the wellbeing outcomes for all Tasmanian children through a public health approach.

Strong Families Safe Kids: Next Steps will deliver 34 actions under five key priority areas of the reform agenda:

1. Child safety and wellbeing is everyone's business
2. Building a common understanding of safety and wellbeing
3. Managing the front door
4. Providing better support for children and their families, and Redesigning the Child Safety Service.

Update on the Australian Child Maltreatment Study 2019-23

You would recall that Professor Ben Matthews joined us early in 2021 for a lunchtime seminar. Please find an update on the ACMS study below:

Launch of survey. We are delighted to advise that the ACMS is on schedule and the main survey fieldwork commenced on Friday 9 April 2021. We anticipate the survey will take around 6 months from April – October 2021. We will interview roughly 10,000 Australians aged 16 and over (through to 65+). We oversample 16-24 year olds to generate particularly strong evidence of the experience of adolescents and young adults.

Nature of the Australian Child Maltreatment Study. As you will recall, the ACMS is the first national study of the prevalence all five forms of child maltreatment in Australia (physical abuse, sexual abuse, emotional abuse, neglect, and exposure to domestic violence). We ask 20 core screener questions about maltreatment experiences across these five domains to identify prevalence rates (these are Yes/No questions). Through subsequent follow-up questions, we then capture information about the nature of these experiences (e.g., age of onset and cessation; frequency; and who inflicted the maltreatment). For sexual and physical abuse we also assess if the maltreatment was ever disclosed. In addition, we examine other Adverse Childhood Experiences (ACEs), peer bullying and sibling victimisation, and out of home placement.

NATIONAL STRATEGY TO PREVENT CHILD SEXUAL ABUSE

As you may be aware, the [National Office for Child Safety](#) (the National Office) is leading the development of the [National Strategy to Prevent Child Sexual Abuse](#) (National Strategy), in partnership with Commonwealth agencies, state and territory governments and the non-government sector. The National Strategy (2021-2031) will be Australia's first strategic policy framework to guide a whole-of-nation approach to preventing and responding to child sexual abuse. It will consider child sexual abuse in all settings including institutional, familial, and online.

With the National Strategy scheduled to be launched in late 2021, the National Office is now undertaking final development consultations. They are inviting participation in consultation and are accepting responses up to **COB Friday 7 May 2021**.

The key objective of the final consultations is to better understand how key stakeholders wish to be involved in the design of the scope, implementation and evaluation of individual initiatives under the National Strategy once it is launched. Our hope is that we will continue to work closely with stakeholders on the implementation of initiatives

SURVEY ON THE MINIMUM AGE OF CRIMINAL RESPONSIBILITY

Take part in a survey to inform the Commissioner for Children's advice to the Tasmanian Government on the minimum age of criminal responsibility!

Currently in Tasmania, as in all other Australian jurisdictions, the minimum age of criminal responsibility is set at 10 years. This means that children as young as 10 can be arrested, searched, charged with a criminal offence, remanded in custody, and sentenced to detention.

In 2019, the UN Committee on the Rights of the Child recommended countries raise the minimum age to what is described as an internationally acceptable minimum of at least 14 years. There is now a groundswell of support for raising the minimum age of criminal responsibility in Australia, with Aboriginal and Torres Strait Islander organisations, the Australian and New Zealand Children's Commissioners and Guardians, and many peak or representative organisations amongst those calling for change.

The Commissioner for Children will be providing advice to the Tasmanian Government on this issue. To help inform the advice the Commissioner is seeking, through an online survey, the views of individuals and organisations with relevant expertise, knowledge, and experience on what raising the minimum age might mean for Tasmania.

FREE WEBINAR: WHAT IS THE SOCIAL MODEL OF DISABILITY AND WHY IS IT IMPORTANT IN CHILD MENTAL HEALTH?

Children living with disability are affected by the same factors that influence the mental health and well-being of other children. However, there are additional considerations that can help practitioners and parents separate a child's social and emotional functioning, communication and behaviour from their disability, and better support them.

This webinar will explore the social model of disability, specifically the three additional factors that influence a child's experience of disability – the nature of the condition, its impact on daily activities and its impact on participation.

Drawing on two case studies, this webinar will:

- Identify how disability can positively and negatively influence children's mental health and wellbeing
- Explore how the social model of disability can inform approaches to practice and parenting to better support children's mental health, wellbeing and development
- Emphasise the importance of seeing the 'whole child', not just their disability.

This webinar is of interest to professionals supporting children living with disability, and/or their families, including disability support workers and allied health professionals.
